



## WAKO 2017 ANTIDOPING ACTIVITY REPORT

WAKO IF Antidoping policy for year 2017 was to test athletes at World and Continental Championships.

Therefore, 10 athletes were tested per each of the following events:

**JUNIOR AND CADETS EUROPEAN CHAMPIONSHIP, all disciplines**  
(event held in Skopje, Fyrom, on September 2017)

**SENIOR WORLD CHAMPIONSHIPS, all disciplines** (event held in Budapest, Hungary, on November 2017)

5 of these tests were classified as Out Of Competition, OOC (samples collected at weigh-in and medical check, before the competitions started) and 5 In Competition, IC (samples collected on winners, just after the final matches). The tests were made on urine samples.

**ASIAN KICKBOXING CONFEDERATION**, affiliated to WAKO, also organized **10 in competition tests** at Asian kickboxing Confederation Championships which were held in **Ashgabat, Turkmenistan**. The samples were collected on winner after the final matches.

Additionally, WAKO had a Registered Testing Pool (RTP) of athletes, to be tested Out Of Competition. Their tests were coordinated for WAKO by the GAISF Doping Free Sport Unit. Each athlete was tested 3 times in the year. Steroidal Module of Athlete Biological Passport was also implemented.

## ANTIDOPING RULES VIOLATIONS

1 Adverse Analytical Findings (AAF) was reported at In Competition Tests (at the World Championship in Budapest); the Result Management process is still in place.

1 Adverse Analytical Finding (AAF) was reported in Out of Competition test (at the European Championships in Skopje); the Result Management process ended with a **4 years disqualification**.

2 additional Adverse Analytical Findings (AAFs) were reported, in one WAKO athlete competing at **International World Games** (held in Krakow, Poland, in July 2017, promoted by IWGA) and in one athlete competing at **Asian Indoor and Martial Art Games** (held in Ashgabat, Turkmenistan, promoted by Olympic Council of Asia). A ban period of **4 years** was finally imposed after the management of both cases.

No Antidoping Rules Violation was committed by the Athletes in the 2017 Registered Testing Pool.
