Introduction

2022 has seen a large growth in the development of Kickboxing within Oceania. With a return to play from the Covid pandemic, a rise in participation has been witnessed, particularly in New Zealand.

2022 has seen the transition of Presidents from Davydd Saunders to Sallie McArdle. Sallie a former WAKO World Champion with over 30 years in the sport, will be a massive addition to the region.



A word from the President

“I am truly excited to take on this role in 2022. Throughout the year we have seen constant growth in NZ and after witnessing the Oceania Championships, we are very excited for the future.

2022 saw the largest Oceania Games to date, and several athletes, from both NZ and Australia, qualifying for the World Combat Games in Saudi Arabia in 2023.

Also noting the strength that both countries showed in Ring and Tatami, we are excited to see our Teams travel to the World Championships in large numbers in the future.”

Community Sport

2022 has seen a strong commitment to community sport in both Australia and New Zealand. WAKO OCEANIA witnessed close to a 1000 athletes competing in Tatami and Ring sport at a local grassroots level.

This commitment to the foundations of the sport is what will see our region grow from strength to strength on the international scene!.

WAKO AUSTRALIA has seen over 25 events in 2022 and over 10 in NZ. These numbers are a testament to the hard work of both leadership teams.

Being so far from Europe and the rest of the world, we have had to build and develop the Oceania region from the ground up. Our National Federations have had to take it upon themselves to push ahead with little or no support from WAKO-IF.

Even with this, we have managed to show the world that our high levels of Sport Education, partnered with a commitment to succeed, can be shown as an example to other nations with similar struggles.

International Teams

Already for the 2023 World Championships Australian Kickboxing has confirmed 40 athletes. We will have several more events, filling hopefully more spots This will be the largest team ever witnessed from Oceania region, and will be among the top 10 largest teams at the World Championships!!! Not bad for a region of kangaroos!!

National Level Sport

Team Australia witnessed 32 Athletes travel to Italy as part of the National Team. With Covid still being a challenge to NZ team unfortunately took the decision not to send a team.

Winning a Gold in K1 2 silvers and 3 Bronze, the Australian team ranked in the TOP 10 at the World championships in K1. This was higher ranking than many strong European countries and a true reflection on the National standard at Australian Events.

CLOSING

2022 saw WAKO OCEANIA host the largest Oceania Championships to date, held at the Olympic training facility in the institute of Sport for Australia.

The level of competition was extremely high and although the competition side was a success, the cost associated with the event left WAKO Oceania in major debt.

This debt is mainly due to the large costs arising from WAKO-IF demands on competition. This debt, along with future financial demands and likely no future international support, now jeopardises the future of these continental events.

It is forcing WAKO Oceania to have no option but to seek advice whether this is acceptable or even worthwhile in the region.
